## **Abstract**

The relevance of the article is due to the increasing role of geopolitical and economic risks associated with the global digital systems' restructuring and the markets' advance by major global players. Evaluation of these processes from a scientific point of view in modern research is extremely difficult due to the digital transformation's high speed. Currently, the international competition of companies, countries and entire regions goes beyond traditional tangible goods and moves into the digital world. The international business' transformation towards the growth of the Industry 4.0 technologies' use: Big Data and artificial intelligence (AI), change the power balance on the world map.
